RISK ASSESSMENT AND TERMS AND CONDITIONS

Canoeing can be a hazardous activity and this should not be underestimated. While in normal conditions the Whanganui River is suitable for inexperienced paddlers, it can be dangerous at some flows. I am making this trip at my own risk and absolve Blazing Paddles Canoe Adventures or any of its agents of any liability for loss or damage while I am on this trip, including any client property that may be lost or damaged. I have no medical conditions that should exclude me from canoeing. I will not go on the river while impaired by drugs or alcohol and will not consume any such substances while on the river. I am happy with the canoe equipment supplied and am confident about making this trip on the Whanganui River without a guide. Damage to the canoes/equipment through normal use will incur no charge, however loss or damage due to flooding at nights, negligence, or any deliberate damage will incur the costs of recovery from the river by jetboat and repair. Any canoe completely lost through flooding will be charged for. Any refunds will be at the sole discretion of Blazing Paddles. To keep costs down we may use other operators to assist with transport to and from the river. You MUST be at the pick up point by the time shown below. We charge \$25 per hour or part thereof for lateness. If there are other clients the driver will wait only one hour before departing for Blazing Paddles' base. They will return to pick you up later the same day but this will incur a minimum extra charge of \$150. To be sure you are on time you must leave your Tieke/Ramanui by 8.30 am on the day of your pick up. Any transport required outside of the standard pick up times will incur an extra charge, unless previously arranged.
